TRADE NEW HIGHLIGHTS – FEBRUARY 2019

1. One hundred and thirty Indian Students Arrested in 'Pay-and-Stay' University Sting Operation

One hundred and thirty students were arrested for their association with Farmington University in Michigan, a fake university set up by the Department of Homeland Security to target foreign students who were staying in the U.S. without proper authorization. All of the arrested students face immediate deportation and could also face criminal charges. A grand jury will next determine whether there is sufficient evidence to charge the students with knowingly committing immigration fraud. The recruiters are charged with conspiracy to commit visa fraud and harboring aliens for profit. They each face maximum sentences of five years, according to ICE. India's Ministry of External Affairs said that it had gained access to 117 of the students arrested by DHS. Indian Embassy and Consulates have obtained consular access to the 117 of them, by proactively visiting 36 different detention sites through the length and breadth of the country.

2. USCIS Launches Online Feature for Checking Asylum Status; Applications for Citizenship

The U.S. Citizenship and Immigration Services announced that it has launched a new feature whereby asylum applicants can check the status of their application online. Only asylum applicants with an application pending with USCIS will be able to use this new feature to check their case status online. It will not cover defensive asylum applicants whose cases are pending in immigration court, the government entity added.

3. DHS Finalizes New Rule Favoring H-1B Applicants With Advanced U.S. Degrees The Department of Homeland Security announced that it has finalized a rule reformatting the H-1B visa program, giving preference to applicants with advanced U.S. degrees. The new rule — which received 814 responses during a 30-day required comment period — will go into effect April 1, just ahead of the 2020 H-1B filing season. Currently, 65,000 H-1B visas are annually allotted via lottery per the H-1B cap; applicants need only an undergraduate degree to be eligible. 20,000 additional visas are currently available for those with advanced U.S. degrees. Beginning April 1, USCIS will now choose those with advanced U.S. degrees first, before selecting other applicants.

4. Indian American Team from MIT, Microsoft Develops Model for Safer Self-Driving Cars

A team of Indian American researchers has developed a novel model that uses human input to uncover Artificial Intelligence "blind spots" in self-driving cars, so that the vehicles can avoid dangerous errors in the real world. The model developed by MIT and Microsoft researchers identifies instances in which autonomous systems have "learned"

from training examples that don't match what's actually happening in the real world. Engineers could use this model to improve the safety of AI systems, such as driverless vehicles and autonomous robots.

5. 12th Annual US Global Business Forum and Summit Pitches Investment in Green Technology

The 12th Annual US Global Business Forum and Investment Summit, with a focus on America and Asia, was held on the iconic Queen Mary luxury liner in Long Beach, California, presented by US Global Holding Enterprises in association with Friends of South Asian American Communities, Armao Global and LA LA Land Development Inc., and Los Angeles Bioscope Film Festival. USGBF is a platform established by leaders of the Indian and American communities with the objective of promoting trade, commerce, investments and joint ventures between the various countries.
