TRADE NEW HIGHLIGHTS – November 2018

1. Trump Plan to Ban Asylum for Those Arriving on U.S.-Mexico Border Could Impact Indian Sikhs, South Asians

President Donald Trump Nov. 1 announced his intent to ban asylum for people arriving on the U.S.-Mexico border, ostensibly to punish the "caravan" of migrants arriving from Central America, but also impacting the thousands of Indian Sikhs and other South Asians who have increasingly been arriving on foot via those pathways. Immigration and Customs Enforcement is housing hundreds of South Asian asylum seekers at a medium security federal prison in Victorville, Calif., where Sikhs are banned from wearing their turbans and provided no access to vegetarian food, in violation of federal laws.

2. Tech Organizations Band Together to Oppose Lawsuit Seeking to End Optional Practical Training Program for International Students

Several technology advocacy organizations have banded together to oppose a lawsuit which seeks to end the Optional Practical Training program, used by many international students studying in the U.S. The OPT program allows foreign students to work for up to 20 hours a week, provided they are working in a capacity related to their field of study. OPT can be used while a student is studying, or after graduation for a period of 12 months. A student who has graduated in a STEM – science, technology, engineering, or math – discipline can apply for an additional 24-month extension of OPT status. Students from India represent the second-largest population of international students in the U.S. China is home to the first. About one-third of international students are enrolled in STEM studies, and about 14 percent stay on to do OPT, noted USCIS.

3. U.S. Colleges File Lawsuit against USCIS for New Policies Adversely Affecting International Students

Four U.S. colleges have filed a lawsuit against U.S. Citizenship and Immigration Services, stating that a new policy which was implemented Aug. 9 adversely impacts international students. Indians constitute the second-largest population of international students, behind China. About 190,000 students from India are currently studying in the U.S. or completing their Optional Practical Training.

Formerly, students who stayed on after their course of study was completed only began to accrue "unlawful presence" after the Department of Homeland Security issued a formal finding of a status violation, or the day after an immigration judge issued an order of deportation. But under the new policy, students begin accruing unlawful presence if they stay on even one day post-graduation. Accruing unlawful presence for

more than 180 days could bar them from returning to the U.S. for a period of three to 10 years.

4. New Indian Consul General in San Francisco Sanjay Panda Aims to Serve Community with Greater Efficiency

Ambassador Sanjay Kumar Panda, who arrived here Nov. 14 to serve as India's Consul General for the West Coast and Guam, hopes to eliminate the slow churn of consular bureaucracy during his three-year tenure in the U.S. Mr. Sanjay Panda replaces former Consul General Ashok Venkatesan, who has retired and moved back to Mumbai. The U.S.-India Strategic Partnership Forum hosted a welcome reception for the new consul general on Nov. 29, in Palo Alto.

His latest posting in the Indian Ocean region gave Panda ample opportunities to interact with the U.S. on maritime security concerns in the area, amongst other issues. Sri Lanka and the Maldives are strategically important to both countries but have a history of political instability, he said, noting that the U.S. and India have worked to develop a collaborative strategy for the region.

5. Arizona State Board of Education Approves Sikhism to Be Included in School Curriculum The Arizona State Board of Education voted to include Sikhism and several other world religions for the first time in its K-12 curriculum. The Board of Education noted that there will be a two-year transition period to implement the revised standards, with full implementation in the school year 2020-2021. "As a result, the Arizona public school system has dramatically improved the state's diversity education and religious literacy relating to Sikhs, other minority faiths and marginalized communities," said the Sikh Coalition – the nation's largest Sikh advocacy group. The Sikh Coalition has worked for more than a year with the Arizona Sikh community to advocate for the inclusion of Sikhism in social studies material.
