TRADE NEW HIGHLIGHTS – April 2018

1. Facebook Admits 500,000 Indian Users Affected by Data Breach

In a first such revelation, Facebook has admitted that the data of nearly 5.6 lakh Indian users may have been "improperly" shared with British political analytics company Cambridge Analytica. In a blog post, Mike Schroepfer, chief technology officer at Facebook, showed country-specific break-downs of people affected by the data breach. While most users are from the U.S. — over 70 million — the data of 562,455 Indian Facebook users has also been shared with Cambridge Analytica."In total, we believe the Facebook information of up to 87 million people — mostly in the U.S. — may have been improperly shared with Cambridge Analytica," Schroepfer wrote.

2. U.S. Suspends Premium Processing of H-1B Visa Petitions Until September - The U.S. March 21 announced the suspension of premium processing of all H-1B visa petitions for the fiscal year 2019. The U.S. Citizenship and Immigration Services said the temporary suspension would help reduce the "overall H-1B visa processing time." The H-1B petition filing is for the fiscal year 2019 beginning Oct. 1, 2018. "We will notify the public before resuming premium processing for cap-subject H-1B petitions or making any other premium processing updates," the federal agency said.

3. 2020 Census Will Include Question on Citizenship, Drawing Ire from Immigrant Community

U.S. Department of Commerce Secretary Wilbur Ross announced late March 26 that a question about citizenship would be added to the 2020 Census. The controversial decision immediately sparked fierce backlash from the immigrant community. The states of California and New York have filed separate lawsuits, noting that asking the question will lead to an undercount of immigrant populations in their states. The U.S. Census — mandated by the Constitution — is taken every 10 years and determines the number of seats a district is entitled in Congress. It also determines the amount of dollars jurisdictions are given for federal projects. More than half a million Indian Americans residing in the U.S. are undocumented. They are likely to be fearful of filling out Census information which asks whether or not they are a U.S. citizen. California simply has too much to lose to allow the Trump Administration to botch this important decennial obligation.

4. Annual TiE Conference Re-Branded as 'TiE Inflect' for 2018, to Highlight Artificial Intelligence -

The Indus Entrepreneurs, better known as TiE, is holding its annual conference which promises to feature some of the best and brightest from entrepreneurs across the country and globe. Formerly known as TiEcon, the organization has changed the name of the conference in its 26th year to TiE Inflect 2018, saying that it is "building on the 25-year legacy of TiEcon." TiE organizers have put together the conference, held at the Santa Clara (Calif.) Convention Center May 4 and May 5, "to focus on the business and human impact of artificial intelligence. The slogan of TiE Inflect 2018 is "Imagination AI."This year's conference, which expects to have more than 5,400 attendees and 1,300-plus industry leaders from 22 countries across the globe, will feature 15 tracks and more than 220 speakers.

5. Google Maps Helps Navigate India's Roads-

Google launched a suite of new features to make getting around the streets and lanes in India easier, according to a Quartz India report. From generating unique area-specific codes to using nearby landmarks to navigate to allowing users to add addresses that don't appear on maps yet, Google is attempting to bring order to the chaos, the report said. The company, which made maps voice navigation available in Hindi in 2014, has now added six new local languages: Bengali, Gujarati, Kannada, Telugu, Tamil and Malayalam. "While some addresses are well-defined by street names and house numbers that are easy to find, others can be long-winded and hard to locate," the company said in a blog post. "The other reality is that millions of people and places in India are hard to locate—especially those in remote areas." Among other features, Google has launched "Plus codes," which divide the geographical surface of the world into "tiled areas," attributing a unique six-letter code and the city name to each of them, the report said.
