#### **TRADE NEW HIGHLIGHTS – July 2018**

#### 1. Kishore Mohanty lead- UT Team Hopes to Energize India

A team of engineers and researchers at the University of Texas at Austin led by Indian American Kishore Mohanty have signed a \$5 million partnership agreement over 10 years with India's Oil and Natural Gas Corporation with the hopes of energizing the country. This new international collaboration will allow UT's Cockrell School of Engineering researchers to share their specialized expertise with people on the ground in India to improve and fortify India's domestic energy industries and, ultimately, lead to greater self-sufficiency, the university said in a news release.

### 2. Indian American Surgeon Atul Gawande to Lead Amazon-Berkshire Hathaway-JPMorgan Chase Health Venture

Indian American surgeon and journalist Atul Gawande has been tabbed to lead the health venture of Amazon.com Inc., Berkshire Hathaway Inc. and JPMorgan Chase & Co. The new firm – meant to help the three companies improve care and lower costs – will be based in Boston, Mass., and Gawande will start in his new position on July 9, according to a Bloomberg report. The health firm will be independent from the three firms, whose leaders formed the group as a way of contending with what Berkshire CEO Warren Buffett called a "tapeworm" eating the U.S. economy, the report said.

#### 3. India, Top Buyer of U.S. Almonds, Hits Back with Higher Duties

India, the world's biggest buyer of U.S. almonds, raised import duties on the commodity by 20 percent, a government order said, joining the European Union and China in retaliating against President Donald Trump's tariff hikes on steel and aluminum. Reuters reported that New Delhi, incensed by Washington's refusal to exempt it from the new tariffs, also imposed a 120 percent duty on the import of walnuts in the strongest action yet against the United States. The move to increase tariffs from Aug. 4 will also cover a slew of other farm, steel and iron products, the report said. It came a day after the European Union said it would begin charging 25 percent import duties on a range of U.S. products June 22, in response to the new U.S. tariffs.

#### 4. Amazon Spearheads \$12M Funding Campaign in India

Acko General Insurance, an online-only InsurTech start-up based in Mumbai, has raised an investment of \$12 million led by Amazon, bringing the company's total equity funding to nearly \$42 million, according to a ReInsurance.ws report. This announcement confirms rumors from January that Amazon was on the verge of making its first investment in the disruptive Indian start-up, which had recently received in-principal approval from the financial market regulators in India, the report said.

#### 6. Indian-Americans donate \$1 billion a year: Indiaspora Survey

Indian Americans, the wealthiest community in the nation, donate an estimated \$1 billion annually to non-profit organizations, but give far less than their potential because of a wariness of how their donor dollars are spent, summated Indiaspora July 17, releasing the results of a first-ever survey of Indian American philanthropy. The survey found a large "giving gap," of \$2-3 billion, and noted that Indian Americans give only one percent of their annual income in charitable contributions. The U.S. population as a whole donates roughly four percent. If Indian Americans contributed at that same rate, they could be donating as much as \$3 billion per year concluded the survey.

#### 6. India's JSW Invests \$500M to Upgrade US Steel Mill

JSW Steel will spend up to \$500 million to upgrade a newly acquired U.S. steel mill, expanding the Indian company's presence in the country amid trade tensions that have seen India raise tariffs on American exports, Nikkei Asian Review reported. The fresh outlays will modernize Acero Junction, located in Ohio. The move lifts JSW's recent U.S. investments to \$1 billion. "It is our intention to further augment our capacity in Acero Junction over the next few years ... to take the combined capacity of JSW USA to 4 million tons per annum, which will be 100 percent American melted and manufactured," said Parth Jindal, director of JSW's U.S. unit.
