TRADE NEW HIGHLIGHTS – May 2018

1. USCIS Receives 190K H-1B Petitions, Allots Less Than Half Via Lottery

U.S. Citizenship and Immigration Services announced April 12 that it had received 190,090 H-1B visa applications for fiscal year 2019. The agency announced April 5 that it had met the numbers needed to meet the congressionally-mandated cap of 65,000 regular H-1B visas, and 20,000 "master's cap" visas. USCIS said it has allotted in total 85,000 visas via a randomized lottery. Immigration analysts had predicted there would be a severe drop in applications this year, given the anti H-1B and "Hire American" rhetoric of the Trump administration. But this year's numbers represent a roughly four percent drop over last year's application numbers: 199,000. However, numbers of applicants have been declining since President Donald Trump took office. For FY 2017 – applications were accepted beginning April 1, 2016 and closed shortly after – 236,000 H-1B petitions were filed. In 2015, applications for FY 2016 totaled 233,000, according to USCIS data.

2. Reforms Help India Retain Fastest Growing Economy Spot, Says IMF Report

The International Monetary Fund says that India will retain its top spot as the world's fastest growing economy, helped by structural reforms and the fading of the effects of demonetization and the new Goods and Services Tax system. According to the World Economic Outlook report released April 17, India's economy is expected to grow at 7.4 percent in 2018 from 6.7 percent in 2017.As per the report, the country's economic growth is expected to be 7.8 percent in 2019.The report predicted that the current year's economic growth will be pushed higher by "strong private consumption as well as fading transitory effects of the currency exchange initiative and implementation of the national Goods and Services Tax.

3. Walmart Makes bid Bet in India, pays \$16B for Flipkart 77% Stake -

Walmart Inc announced that it would pay \$16 billion for an initial stake of approximately 77% in homegrown e-commerce company Flipkart. The deal values Flipkart at \$20.8 billion, according to sources. "India is one of the most attractive retail markets in the world, given its size and growth rate, and our investment is an opportunity to partner with the company that is leading the transformation of e-commerce in the market," said Doug McMillon, Walmart's president and chief executive officer, in a statement. While Walmart and Flipkart will leverage their combined strengths, they will maintain distinct brands and operating structures. Walmart are facing the heat from Amazon in the U.S market. They don't want to repeat the mistake they did in the U.S where they gave a lot of time to Amazon to get access to the customer wallets.

4. India's Biggest Renewable-Energy Deal Has Been Sealed -

Goldman Sachs-backed ReNew Power has acquired three-year-old Ostro Energy to create the country's largest clean energy firm by installed capacity, Quartz reported. In what is the biggest ever deal in the Indian renewable energy sector, ReNew Power will spend about \$1.5 billion for the acquisition. Ostro Energy's 1,100 megawatt of capacity is spread across Andhra Pradesh, Karnataka, Telangana, Rajasthan, Madhya Pradesh and Gujarat, the report said. This deal could be the first in a wave of consolidation India's renewable sector is likely to witness this year. The main triggers are the sharp decrease in clean energy tariffs and the consequent fall in the internal rate of return — the yield an investor gets on his investment, the report said.
