MONTHLY COMMERCIAL REPORT— MARCH 2011

I. Major Commercial and Trade-Related Events

Mahindra & Mahindra Ltd of India and Cisco of San Jose (California) announced on 8th March, 2011 the signing of a comprehensive Memorandum of Understanding (MOU) under which the parties intend to collaborate on go-to-market strategies in areas that include smart cities, virtual dealership, sports and entertainment, and cloud services. Under the non-binding MOU, Cisco and Mahindra will explore opportunities to collaborate on comprehensive differentiated offerings in the sports and entertainment market to provide a range of industry-specific offerings. These include the Cisco Connected Stadium platform and the StadiumVision[®] solution using the network as a platform, with additive elements for access control, wireless, RFID, smart-card ticketing and loyalty programs, points of sale, and hospitality. They will also explore working together to build the private cloud roadmap for the Mahindra Group across different Businesses - Mahindra & Mahindra, Tech Mahindra and Mahindra Satyam¹.

Abound Solar², a Loveland, Colorado, US based leading manufacturer of cadmium telluride thin-film photovoltaic solar modules, announced on 22nd March 2011, a long-term sales agreement with Solar Integration Systems India Private Limited (Solarsis) of

Hyderabad, India. The companies will work together to provide solutions based on Abound's next generation thin-film modules serving project developers in the Indian market. Solarsis will also establish a test facility with the purpose of optimizing balance of system (BoS) designs around Abound Solar's modules that will lower total system costs for customers. The first project under this agreement will be a 1 megawatt ground-mount array in Ananthapur, AP, India³.

As a follow up to their trade mission in November 2010, the Washington State and India Trade Relations Action Committee (WASITRAC) returned to India together with officials of Port of Seattle and signed a sisterport MOU with Dhamra Port, Orissa, India on 12th March, 2011. The Dhamra Port Company Limited (DPCL) is a joint venture of L&T and Tata Steel. The Dhamra Port is one of the deepest ports of India with a depth of 18 meters, which can accommodate super capesize vessels up to 180,000 DWT. The location of Dhamra Port, in close proximity to the mineral belt of Orissa. Jharkhand and West Bengal and its deep draft suitable for large vessels has made Dhamra Port a costeffective and efficient port on the eastern coast of India. The sister-port agreement between Port of Seattle and Dharma will provide opportunities for information sharing port operations, on management, construction, and technology through biannual conferences, trade delegation visits or

informal contacts. The Port of Seattle CEO had a meeting with Orissa State Chief Minister Mr Naveen Patnaik and his cabinet to discuss various future collaborations with Orissa ports for development of sea-trade and cruise activities⁴.

Zynga Inc of San Francisco, California, USA announced on 10th march, 2011 the opening of Studio - 1 in Bangalore, India. This will be its largest studio outside of USA. This center will develop new features for about eight current games from Zynga including Vampire wars, YoVille and FishVille. The studio will take full ownership and responsibility for the conceptualization of new features, development and online marketing. Further down the line the studio may conceptualize and develop entirely new games. Zynga already has a development center in Bangalore employing 100 which will double by the end of 2011^5 .

California Pizza Kitchen (CPK) Inc a Los Angeles, California, USA based company announced on 10th March, 2011 that it had opened a second restaurant in Mumbai, India in conjunction with its franchisee JSM GGC India Pvt. Ltd. (JSMGGC). JSMGGC plans to open 15 new outlets in India over the next five years⁶. The company is already planning to open a third outlet by the end of May 2011.

A few companies from California, USA and other regions of USA set up stalls at the AAHAR 2011 International Trade Fair in New Delhi, under the support of ITPO from March 10-14, 2011. Food Products, all kinds of Foods and processed food, beverages, food processing and packaging machinery, etc. were showcased at this event. The US companies included California Prune Board, Conagra Foods Inc, US Apple Export Council, Cambro Manufacturing Company, US Pecan Growers Council, Food Export Association of Midwest USA and Food Export USA North East.

Some studies published indicate that Bay Area CEO's and executives are confident the region's economy is stabilizing and meeting expectations in the post-recession recovery.

The responses of the 485 CEO's and top executives in the nine Bay Area counties reported in a Bay Area Council report indicates that overall, 58% think Bay Area economic conditions are better than six months ago, up 11 points from last quarter's survey. In addition, 61% said they expect a better Bay Area economy six months from now, up 8 points from last quarter. Things are also looking up for hiring - 31% of executives stated they planned to increase their workforce. The picture improves further in San Francisco and Santa Clara counties with 45% and 38% of executives in those counties, respectively, planning to hire within the next six months. Additionally, executives in specific industries are showing much more confidence that things will be better in six months in their sector. 60% of executives in information technology, 62% of financial services executives and 67% of leisure and hospitality executives expect their industry conditions to improve.

IX. Potential Areas For Trade And Investment

Oregon State: The twenty-eighth largest state exporter to India from the USA in 2010 was Oregon. This has slightly decreased from \$127.5 million in 2009 to \$118.1 million in 2010. Chemicals was the largest export from Oregon to India in 2010 at \$43.173 million which made up 36.5% of total exports from the state to India. Chemicals was the main reason for the drop in exports to India from the state which has fallen from the 2009 figure of \$82.142 million, representing a drop of over 50%. This was followed by Paper at \$28.113 million making up 23.8% of total exports from the state to India. Computer and Electronic Products exports from the state to India represented \$21.639 million at 18.3% of the total exports to India.

Imports from India into USA via Oregon was \$111 million compared to \$120 million in 2009, a 8% drop giving the rank in worldwide imports into the state of 16th . The decrease is even larger when compared to 2008 when Oregon's imports from India stood at \$229 million with a ranking of 13th.
